PEACE PLUS is a €1bn social, economic and environmental investment Programme

It comprises six themes, which encompass 21 individual investment areas.



PEACE PLUS and cross border economic development

Peace and prosperity are intrinsically linked and the PEACE PLUS Programme will support cross border economic development by SMEs.

The Programme will be managed by the Special EU Programmes Body, a cross border body established within the Good Friday Agreement.

PEACE PLUS will support SMEs in Northern Ireland and the border counties of Ireland to tackle specific challenges and opportunities along with facilitating the involvement of partners outside of the programme area.

How PEACE PLUS will benefit SMEs

Theme 2: Delivering Economic Regeneration and Transformation has an indicative budget of €143m to support SME cross border economic development by investing in:

- (iii) existing and emerging skills requirements within their sector (2.3 Programme Area Skills Development); and
- (iv) ways in which digital developments will improve their business (2.4 Smart Towns and Villages)

All of the above should be considered within the context of what has been proposed by the SEUPB within the Consultation Information Document https://www.seupb.eu/PEACEPLUS. This will inform the development of PEACE PLUS projects to benefit SMEs across the Programme area and beyond.
