The Multiple Adverse Childhood Experiences (MACE) Project represents an exciting opportunity to develop a new approach to engaging families with children aged 0-3 and 11-13 who are at risk of not achieving their full potential. The MACE Project will identify and engage 3,125 families and provide early intervention and nurturing supports within their own homes and communities on a cross-border basis.

Five Trauma Informed Cross-Border Networks of Excellence will be created to share best practice, knowledge and learning to enhance cross-border cooperation during and after the project.

“Prevention and early intervention are critical to the reduction of trauma in the lives of vulnerable children. This EU-funded programme, which crosses many sectors, is a strong step in the identification of and support for such children and their families.
