The project will tackle the sectarianism, discrimination, racism and exploitation of EU and non-EU migrants in precarious and insecure sectors of the labour market, along the Border Region of Ireland and Northern Ireland.

One of the key objectives will be to conduct research on the profile, cross-border dynamics, and issues impeding labour market integration of black and minority ethnic (BME) workers in the agricultural, and food processing businesses sectors in Donegal/Derry, Cavan/Armagh, Monaghan/Newry-Down.

A further objective will be to develop a new and innovative model of labour workers market integration to increase the capacity of BME to secure their labour rights and enhance their leadership skills.
